

I have audited the accounts of the ALL GUJARAT VETERINARIAN'S SOCIETY SECURITY TRUST for the year ended on 31<sup>st</sup> March, 2013 and in my opinion and to the best of my information and according to the explanations given to me, I report as follows:

1. The accounts are maintained regularly and in accordance with the provisions of the Act and Rules.
2. The Receipts and disbursements are properly and correctly shown in the accounts.
3. Cash balance and vouchers are in the custody of the Accountant of the Trust on the date of audit and found in agreement with accounts.
4. Books, deeds, account vouchers and other documents and records required by us were produced before me.
5. Inventory, certified by the trustees, of the movables of the trust has/has not been maintained. - N.A.
6. The Accountant/Trustees appeared before me and furnished the necessary information required by me during the course of audit.
7. No property of the Fund of the Trust was applied for any objects or purpose other than the objects or purposes of the Trust.
8. The Death Faternity Contribution of Rs. 53,200/- is outstanding for more than one year and amount written off is NIL for the year 2012-13.
9. That tenders were/were not invited for repairs or construction as the expenditure involved did/did not exceed Rs. 5,000/- for the year 2012-13.
10. No money of the Trust has been invested contrary to the provision of Section 35.
11. No alienations of the immovable property have been made contrary to the provision of Section 36.
12. During the year, Rs. 100,000/- was transferred to Education Promotion Corpus Fund as approved in the Annual General Meeting dated 3<sup>rd</sup> February, 2013.

NOTES FORMING PART OF ACCOUNTS

1. **Basis of Accounting:**

The accounts have been prepared under the historical cost convention based on mercantile basis in accordance with the generally accepted accounting principles in India and the Accounting Standards issued by the ICAI.

- Investments are stated at the cost of acquisition plus interest received/accrued on that, if any.
- Previous year figures are regrouped and re-arranged wherever necessary.
- Amount is rounded off to the nearest rupee value.
- Advanced Faternity Contribution of Rs. 2,500/- received from each member enrolled during the year and such amount is adjusted at Rs. 425/- per member on the death of the member, if any, during the year.
- Trust could not claim refund of TDS of Rs. 20,287/- for non-filing of return of Income for Assessment Year - 2004-05, 2005-06 and 2006-07 and has claimed short refund of TDS of Rs. 6,746/- for Assessment Year 2003-04, 2007-08 and 2008-09.
- Out of 91,408/- paid to Charity Commissioner for various years, amount of Rs. 62,772/- is disputed and subject matter of appeal against the Charity Commissioned Office.
